- We would like to congratulate Ms. Ryann Miller our English Language Arts Coach who was recently named a Nationally Board Certified Teacher as an Early Childhood Generalist.
- On January 10, 2018, we completed our Q2 writing assessment scoring session. Teachers brought completed students writing assessments and scored these as well as had time to input the scores into Galileo. They met in grade level teams reviewing the rubric, performing calibration exercises with your student work; identifying a High, Medium and Low within your class samples so that the calibration time ran smoothly.
- We welcomed two new teachers this week filling open positions. We have one other new teacher starting next week. Many thanks to everyone's diligent efforts to fill our classrooms with enthusiastic teachers!
- Dos Rios implemented a new initiative this year to increase student achievement. Our new Rising Rockets Club is up and running and this week we had our first parent introduction / induction night. The new program is based on best practices for parent involvement. We were excited about the turn out and the responses from the parents were overwhelmingly positive
- Hurley Ranch welcomed back students for the start of quarter three. We proudly acknowledge the progress in discipline, as we had no discipline referrals during the first three days of school. Ms. Richards and each team of teachers refined the framework for our classroom expectations and protocols for addressing off task behavior during grade-level meetings on Tuesday. We thank our teachers for their hard work in the classroom and recognize the students for their efforts. The annual Spelling bee would not have been a success without the amazing Ms. Arthur. Her hard work and dedication made this year's event a huge success. We would like to congratulate this year's winner Lei Lani Lee and the runner-up Nicholas Marrow. They will represent Hurley Ranch in the district's Spelling Bee.
- Union Elementary held classroom spelling bees the week before Winter Break, first and second grade classrooms participated in classroom spelling bees and selected their classroom representative and their alternate. On Friday, January 12th, each classroom speller will compete in a School-Wide Spelling Bee at Union Elementary. The first and second place winner will go on to compete in the District Spelling Bee on January 24th.


